1. Receipts will not be issued for payments made through the auto debit facility. I will refer to my

credit card statement for confirmation of payments.

2. I must inform SLCB in writing of any changes pertaining to the credit card, including new account numbers, termination or cancellation of credit card accounts at least 30 days before the

next membership account due date.

3. SLCB reserves the right, at its own discretion, to change the Terms & Conditions herein without

prior notice to me.

4. SLCB may at its absolute discretion at any time without prior notice, terminate this authorization

without assigning any reason and there upon shall be under no obligation to debit my credit card for payment

for payment.

5. This authorization will remain effective notwithstanding my death, incapacity or revocation of

this authorization by any other means until SLCB received written notice of the same.

6. SLCB is under no obligation to honor any auto debit instruction unless there is sufficient available

credit limit in my credit card account at the same time the payment is due.

7. In the event that any money is refunded by SLCB for any reason, SLCB is authorized to refund the money to me and shall thereafter be discharged from all obligations pertaining to the same.

Should any dispute arise, both the Member myself shall refer only to each other for remedies and

resolutions.

8. SLCB shall not be held responsible or liable for any claims, loss, damages, costs and/ or expenses

arising from the successful and unsuccessful processing of the debit due to exceeding credit limits, malfunction of the systems, electricity failure and/ or other factors beyond the control of

SLCB.

9. This authorization shall remain binding upon me until SLCB's receipt of my written notification

to cancel the authorization.

10. SLCB is entitled to disallow any debit from my credit card upon notice of my death or

bankruptcy.

11. In the event of any inconsistency, the English version of this document shall prevail over all

versions.
